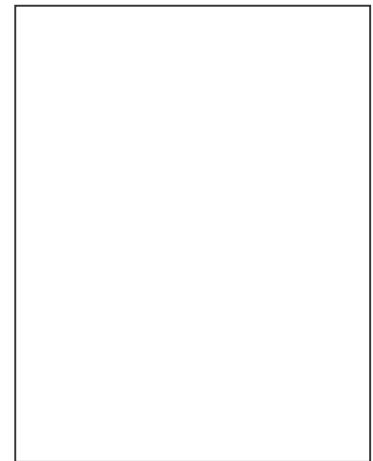

**We are currently an Early Learning and Childcare Partner Provider for the City of Edinburgh Council. We will remain in partnership with the City of Edinburgh Council for session 2020/21 and nursery funding will remain in place for this academic year. As the Scottish Government assesses the proposed schedule for increased funded childcare provision we will continue to monitor and review the status of our partnership. Our priority is always to maintain our high-quality standard of care and early level education and any future decisions taken will be to uphold this ethos. We will endeavour to ensure that our nursery community is consulted and informed ahead of any changes to our partnership status with the City of Edinburgh Council.**

4. authorise the pupil's current nursery (or school) to (a) confirm to the school whether all fees in respect of the pupil have been paid to that current nursery (or school) and (b) disclose to St George's information on the pupil (e.g. academic report and pupil profile), and authorise St George's to disclose this application and authorisation to the current nursery (or school).

If the school offers a place for the pupil, then the offer shall be deemed to have been declined and refused if an acceptance has not been received by us within the time stipulated in the offer.

A deposit of £300 should be paid as a final entry fee when the offer of a place is confirmed. Deposits will be offset against the pupil's account for the final term.

If there are any circumstances (including any disability or medical condition) which might require the pupil to be given special assistance at the school or of which you think the school should be aware, please give details to the school in a separate letter to accompany this form.

The placement of pupils is at the discretion of the Head.

**A minimum of one term's notice of withdrawal from the school is required. When one term's notice of withdrawal from the school is not given, payment for the next term will be required in lieu of notice. No return of fees is made in case of absence during part of a term.**
