- 1. Hereby apply for a place at St George's for the applicant, with effect from the admission date specified;

The placement of applicants is at the discretion of the Head.

A minimum of one term's notice of withdrawal from the school is required in writing to the Head. When one term's notice of withdrawal from the school is not given, payment for the next term will be required in lieu of notice. No return of fees is made in case of absence during part of a term.
